Preface

Economic Census is the complete count of all entrepreneurial units located within the geographical boundaries of the country. The main purpose of conducting Economic Census is to generate an updated frame of enterprises for detailed follow-up surveys. It provides essential data on number and distribution of enterprises engaged in different types of economic activities, which forms the basis, mainly, for the detailed follow-up surveys. The results of these censuses also provide basic entrepreneurial data relating to different sector of the economy for the purpose of planning, development and research etc. specifically for unauthorized sector of the economy. Thus, in a developing country like ours, Economic Census is the only answer to reach the unorganized sectors.

The Fifth Economic Census was conducted in Nagaland from April-May, 2005 by the Directorate of Economics & Statistics, Nagaland in cooperation with the District Administration and Directorate of School Education. There are certain new features in the Fifth Economic Census. Addresses of the enterprises employing 10 workers or more were collected for the first time through Address Slip. In the present report, a broad analysis of the result arrived on the basis of massive data collected during the Fifth Economic Census-2005 are discussed. The report also throws light on number on number of establishments, the employment in agricultural and non-agricultural sectors separately with rural and urban break up including types of establishments, total employment, hired workers employed and female workers, etc. It presents the data relating to the important characteristics of the establishments like seasonality, working without premises, use of fuel/power and types of ownership etc.

At present, the country does not maintain a Business Register. The directory of enterprises to be generated from the Address Slip which would be the basic input for preparation of a Business Register. For the first time, data collected in the Fifth Economic Census are processed through Intelligent Character Recognition (ICR) Technology.

Conduct of the Fifth Economic Census is a single gigantic exercise which was conducted in the State within stipulated time. I would, therefore, place on record my appreciation to all the Officers and Staff of Directorate of Economics & Statistics, Nagaland and Officers of the District Administration and Directorate of School Education engaged for completing the field work and also for manual compilation of the provisional results.

It would also like to thank the Director General, Central Statistical Organisation, Govt. of India and his officers for technical guidance and full support from to time in carrying out this Fifth Economic Census operation in Nagaland. The Officers and Staff of the Directorate of Census Operations, Govt. of India, Assam, Guwahati, also deserve appreciation for undertaking the task of computerization of all the Schedules.

I also place on record the valuable services rendered by officers and staff of Directorate of Economics & Statistics, Nagaland including those of the computer Section under the able guidance of Shri. I. Chuba Jamir, Deputy Director and the Nodal Officer of the Fifth Economic Census and also in bringing out this report.

It is hoped that this report would be useful to planners, research workers and others who are involved in development activities in the State.

PART -I

CHAPTER-I

Introduction

- 1.1 For formation and implementation of any development schemes/projects systematic planning is essential. The prerequisite for such planning is the availability of timely reliable data at the grass root level pertaining to different sectors of the economy update time to time.
- 1.2 With a view to plug the data gaps in the un-organised non-agricultural sector of the economy and the have a comprehensive data on un-organised sector at regular intervals, a country wide Economics Census was launched in 1977, 1980,1990 and 1998. The economic Census is being carried out periodically to collect more information on economic activity, especially for the un-organised sector. It is organized by the central statistical organization, Govt. of India with the close co-operation of the states Directorate of Economics & Statistics. The main objective of the Economics Census is to provide information on distribution of enterprises and their entrepreneurial activities like location of enterprises, description of activities of the enterprise, nature of operations, type of ownership power/fuel used, number of persons employed regularly on hired basis etc. Follow up sample surveys were also conducted, after Economic Census with the objective of collecting more detail information on inputs-outputs, employment, investment made etc.
- 1.3 The first Economics Census was conducted in the year 1977 and which covered only the non-agricultural establishment in the country.
- 1.4 The second, third and the fourth Economics Census were carried out in 1980, 1990 and 1998 respectively. In these surveys, all the agricultural as well as non-agricultural enterprises were covered. However, the enterprises relating to crop production and plantation were excluded from the purview of the census.
- 1.5 The present Economic Census is the fifth in the series. It also covered all agricultural and non-agricultural enterprises excluding those engaged in crop production or plantation within the geographical boundary of the country. Address of the enterprises employing 10 workers or more were also recorded for the first time in this survey through Address slip. The central statistical organization was responsible for Technical aspects of the census including the designing of the schedules, preparation of instructions, providing software for data entry, validation and tabulation etc. Whereas the responsibility of conducting the census with the help of the state Administration was vested with the state Directorate of Economics & Statistics.

Scope and Coverage

- 1.6 The fifth Economic Census under took a complete enumeration of entrepreneurial activities other than crop production and plantation in both rural and urban areas of the country. Data were collected on various aspect of an enterprise, namely, its location, description of activity, type of ownership, social group of owner, power/fuel used, registration status, source of finance, number of persons by sex usually working in the enterprises etc.

Concepts and definitions.

- 1.7** Enterprise:- An enterprise is defined as an undertaking engaged in production and distribution of goods or services not for the sole purpose of consumption.

Enterprise without premises-An enterprise that carries on its activities in open area or outside any census building/house is treated as an enterprise without premises e.g Roadside vending hawking etc.

Non-perennial enterprise- A non perennial or seasonal enterprise is one that carries out its operation only for a certain of the year or season but on a fairly regular basis.

Agricultural enterprise-An enterprise engaged in any of the activities relating to life stock production, agricultural services, hunting, trapping and game propagation, forestry, logging and fishing is defined as an agricultural enterprise.

Activities pertaining to crop production and plantation were not covered in this Census.

Non-agricultural enterprise-All enterprises engaged in activities other than those stated above, are non-agricultural enterprises.

Own account enterprise- An enterprise which is operated only with the help of the members of the household of the owner is termed as an account enterprise.

Establishment- An enterprise which is operated with the help of at least one hired workers on a fairly regular basis is defined as an establishment. Establishment has been further classified as Directory (D) and Non-Directory (ND). Establishment employing six or more workers (household plus hired) are termed as Directory establishment and the establishment employing less than six workers are defined as Non-Directory establishment.

Field operation:

- 1.8** The field work of the fifth Economics Census 2005 was taken up in the state during the period from April to May 2005. Personnel from the Administration, School Education Department and Directorate of Economics & Statistics were drawn and appointed as charge officers, Supervisors and Enumerators to carry out field work.

State Level Training for charge officers and District Statistical Officers has been imparted by the officers and staff of the Economics & Statistics. The charge officers and District Statistical officers and staff in turn imparted training to the supervisors and enumerators at the District and circle levels.

Forms canvassed in the census.

- 1.9** Four types of Schedules were canvassed viz. (1) House list-cum-enterprise Scheduled, (2) Enterprise Scheduled, (3) Enterprise Abstract and (4) Address slip. The Enumerators were required to list all the households and enterprises within the enumeration units allotted to them in the House List-cum-enterprise Scheduled. They also had to fill in the enterprise Scheduled form with detail information on enterprises during listing.

Quick Tabulation and Provisional result.

- 1.10** Based on House List-Cum-Enterprise Scheduled, Enterprise Abstract Scheduled and Address slip, quick tabulation results were prepared and compiled manually in the format prescribed by the Central Statistical organization. It has included important results of selected items such as total number of agricultural and non-agricultural enterprises, total and hired employment with male and female break up etc. These provisional results were submitted to CSO and after approval were made available to all concerned.

Data Processing.

- 1.11** The Data collecting through House list-cum-Enterprise Scheduled, enterprise Scheduled, Enterprise abstract and address slip were properly scrutinized and coding of the activities as per NIC, 2005, etc were undertaken by the staff of Economics Census Section in the Directorate of Economics & Statistics.
- 1.12** Finally data entry, validation, tabulation etc were done by the Directorate of Census Operation, Guwahati Assam.

CHAPTER – II

2. RESULTS AT A GLANCE.

2.1 Number of enterprises in Agriculture and Non-Agricultural sectors.

As per Economic Census 2005, there are 35578 agricultural (other than crop production and plantation) and non-agricultural enterprises in Nagaland, of which 19970 (56.13%) are located in rural areas and 15608 (43.87%) enterprises in urban areas. The number of agriculture enterprises is 1277 (3.59%) while that of non-agricultural enterprises is 34301 (96.41%).

There are 18740 (52.67%) own-account enterprises as against 16838 (47.33%) establishments, of the own-account enterprises 11333 (60.47%) are located in rural areas and 7407 (39.53%) in urban areas. Out of 16838 establishments 8637 (57.29%) are in rural areas and the remaining 8201 (48.71%) in urban areas.

Of the total 1277 agricultural enterprises 648 (50.74%) are own-account enterprises and 629 (49.26%) are establishments. Of the 648 own-account enterprises 510 (78.70%) are in rural areas while 138 (21.30%) in urban areas. The number of Agricultural establishments in rural areas is 483 (76.79%) and that in urban areas is 146 (23.21%). Of the total non-agricultural enterprises numbering 34301, 18092 (52.74%) are own-account enterprises, while 16209 (47.26%) are establishments. Rural areas account for 10823 (59.82%) own-account enterprises as against 7269 (40.18%) situated in urban areas. The number establishments between rural and urban area is 8154 (50.31%) and 8055 (49.69%) respectively.

2.2 Persons usually working in agricultural and non-agricultural enterprises.

The total number of working persons in all the 35578 enterprises in the State is 175169 of which 123130 (70.29%) are hired workers. Of the total workers 7550 (43.14%) are in rural areas and the remaining 99599 (56.86%) are in urban areas. The number of hired workers in rural areas is 48128 (39.09%) and that in urban areas is 75002 (60.91%). The total number of female workers is 42359 (24.18%) of which 18717 (44.19%) is the number of rural areas and 23642 (55.81%) of urban areas.

Out of 175169 workers in the state, 3887 (2.22%) are engaged in Agricultural enterprises and 171282 (97.78%) are engaged in non-agricultural enterprises. Of the 3887 workers in agricultural activities 2958 (76.10%) are in rural areas 929 (23.90%) are in urban areas.

Similarly, out of the total 175169 workers in non-agricultural activities 75570 (43.14%) are in rural areas and the remaining 99599 (56.86%) in urban areas.

2.3 Major activity-wise distribution of Non-agricultural enterprises.

If the total 34301 non-agricultural enterprises in the State, the largest number 18182 (53.00%) come under major-activity group of retail trade. Manufacturing account for 4087 (11.92%) enterprise, other community personal services 2919 (8.49%), Education 2318 (6.76%) Hotels & Restaurants 1925 (5.61%), Public Administration Defence Social Security 1470 (4.29%), Health & Social work 96 (2.80%), Sale, Maintenance and Repair motor vehicle & motor cycle 702 (2.05%), Post and Telecommunication 643 (1.87%), Real Estate Banking & service 401 (1.17%), Transport & Storage 348 (1.01%), Wholesale trade 182 (0.53%) and other activities 1 (0.00%) enterprises.

2.4 Selected characteristics of enterprises.

The characteristics of 1277 agricultural enterprises are as under: 83 agricultural enterprises are operated seasonally, 746 are without premises, 2235 run without power, 2461 are under private ownership, 4 is cooperative, 89 are govt., 36 are private NPI, 103 are owned by scheduled castes, 2164 by scheduled tribes, and 119 enterprises by OBCs.

Out of the total 34301 non-agricultural enterprises, 1782 are seasonal, 982 are without premises, 112373 run without power, 41171 are private ownership, 15092 are private NPI, 280 are cooperatives, 83526 are Govt., 7194 are owned by scheduled castes, 23582 by scheduled tribes are owned by OBCs.

2.5 Number of enterprises and employment by size class of employment.

Table 2.3 gives the details of enterprises and employment by size class of employment. The number of size class of employment. The number of size class 1 to 5 in all enterprises are 29489 (82.88%) and 4397 (12.36%) and 1692 (4.76%) of the enterprises are accounted for by size classes 6 to 9 and 10 above 16252 (45.68%) of the enterprises in the rural areas fall under size class of employment 1 to 5, whereas 2725 (7.66%) and 993 (2.79%) of enterprises fall under the size classes 6 to 9 and 10 above. In the urban areas, the size class with 1 to 5 employees accounted for 13237 (37.21%) of the total enterprises, whereas the size classes 6 to 9 and 10 above employment for 1672 (4.70%) and 699 (1.96%) respectively.

The enterprises in size class 10 and above which constituted only 1692 (4.76%) of enterprises at State level, accounts for 109484 (62.50%) of the total persons usually working in all enterprises. The number of employment for this group in the rural and urban areas is 993 (2.79%) and 699 (1.96%) accounts for 42243 (24.12%) and 67421 had the maximum number of enterprises in rural as well as in the urban areas accounted for 18337 (10.47%) and 13501 (7.71%) of the total employment in their respective areas.

2.6 Inter-district comparison on concentration of enterprises with respect to population and areas.

From table 2.10 it is observed that the number of enterprises vary from 8573 in Dimapur district to 2317 in Mon district. While Kohima district has 8522 enterprises, Tuensang district 4050, Mokokchung district 3483. Phek district 3075, Wokha district 2877 enterprises and Zunheboto district 2681 respectively. Dimapur district has the largest concentration (24.10%) of enterprises, the other districts together sharing on (75.90%) of the enterprises.

Further it is observed that the number of enterprises per 1000 population varies from 28 in Dimapur district to 9 in Mon district. The other districts possessing 27 or lesser number of enterprises per 1000 population. Again it is seen that the concentration of enterprises per 10 sq.km area is 92 in Dimapur district with Tuensang having as low as 10 enterprises. The corresponding figures for the remaining districts vary from 27 to 13 enterprises. Again table 4.5 shows that the largest number of non-agricultural enterprises are covered under six major activity groups viz-Retail trade, Manufacturing, Other Community, Personal services, Education, Restaurants & Hotels, and Public Administration Defence Social Security in all the eight districts. As regard to retail trade the highest concentration of 5018 enterprises in Kohima district while Wokha district registering the lowest of only 1160 units. The remaining districts have enterprises numbering from 4674 to 1282. In manufacturing, Dimapur district has the largest number of 911 enterprises with the figures for other districts varying from 660 to 221 units. In other community, social & personal services, Dimapur district has the largest number of 623 enterprises with the figures for other districts varying from 559

to 155 units. Similarly, Tuensang district has the maximum numbers of 464 education while the numbers for the remaining districts vary from 371 to 211 units, Kohima district has the largest number of 670 restaurants & hotels with the figures for other districts varying 531 to 102 units again Kohima district has the largest number of 281 Public Administration, Defence Social Security with the figures for other districts varying from 231 to 106 units.

Table 4.24 reveals that under retail trade 1154 (22.98%) non-agricultural establishments are located in rural areas and 3867 (77.02%) in Urban areas. In other community per service there are 1819 (76.53%) establishments in rural areas as against 558 (223.47%) in urban areas. The number of education in rural areas is 2017 (88.16%) while that of in urban areas is 271 (11.84%). Overall, 8154 (50.31 %) establishments are located in rural areas and 8055 (49.69%) in urban areas.

2.7 Results of 1980, 1990, 1998 and 2005 Economic Census in respect of non-agricultural establishments-comparison.

In table 2.11 comparative trend of progress from 1980 through 1998 to 2005 in respect of some selected information pertaining to non-agricultural establishments is depicted according to rural/urban location. It is observed that the sharp trends of increase in both the number of establishments and the number of workers from 1980, 1990 and 1998 prevailing upto 2005 as well for both the rural and urban areas. However, decrease is indicated in number of persons usually working in non-agricultural establishments and number of hired workers working in non-agricultural establishments in urban sector.

CHAPTER – III

3. PRINCIPAL CHARACTERISTICS OF AGRICULTURE ENTERPRISES.

3.1 *Number of enterprises and total person employed in agricultural own- account enterprises and agricultural establishment-inter-district comparison.*

(a) Number of agricultural OAE, Table 3.3 : It is observed that the highest number of OAE in rural areas is 260 (50.98%) in Mokokchung district and 83 (60.14%) in urban areas in Kohima district. The number of enterprises in other district vary from 2 (0.39%) in Mon district to 98 (19.22%) in Phek district for rural areas and in urban areas from 1 (0.73%) in Phek district to 34 (24.64%) in Dimapur district and Mon and Tuensang districts do not have such enterprises in urban areas.

(b) Number of agricultural establishments, Table 3.14: In case of agricultural establishments Mokokchung district has the highest concentration of 242 (50.10%) in rural areas and 61 (41.70%) in Dimapur district for urban areas. The number other districts in rural areas vary from 6 (1.24%) in Tuensang district to 132 (27.33%) in Wokha district. The number of other districts in urban areas vary from 4 (2.74%) in Phek district to 35 (23.97%) in Kohima district. Mon district does not have such enterprise in urban area.

(c) Number of workers in agricultural OAE, Table 3.4 : In rural areas Mokokchung district has the highest number of workers of 469 (49.22%) and Zunheboto has the lowest of 10 (1.05%) workers. In the case of urban areas Kohima district has the highest number of workers of 229 (68.36%) and Phek district has the lowest of 2(0.60%) workers. Tuensang and Mon do not have such workers in urban area.

(d) Number of workers in agricultural establishments, Table 3.15 : Mokokchung district has the highest 791 (39.45%) workers in rural areas and 223 (37.54%) workers in Dimapur district in urban areas. The number of workers in other districts vary from 13 (0.65%) in Zunheboto district to 703 (35.06%) in Wokha district for rural areas. While in urban areas the number of workers vary from 7 (1.18%) in Phek district to 161 (27.11%) in Kohima district. Mon district does not have such workers in urban area.

3.2 *Number of establishments and employment in private and co-operative vis-à-vis the total establishment/employment.*

Table 3.25, 3.26, 3.27 show that out of 629 agricultural establishments 483 (76.79%) are situated in rural areas and 146 (23.21%) in urban areas. The total number of workers in the establishments are 2599, out of which 2005 (77.15%) are employed in rural areas and 594 (22.85%) in urban areas.

Of the 483 rural establishments, 469 establishments are in Private Un-incorporated Proprietary, 5 are in private Non-Profit Institute, 6 are in Government and PSU, 3 are in Private Others establishment, out of 146 establishments in urban areas 135 establishments are Private Un-incorporated Proprietary, 5 are in Private Non-Profit Institute, 2 each in Government and PSU and Private Others.

3.3 *Number of own-account enterprises and establishment by size class of total employment at state level and by rural/urban.*

(a) Table 3.8 reveals that out of the total number of 648 OAEs in the state, 289 (44.60%) OAEs come under the employment size class of 2 workers, 211 (32.56%) OAEs under 1 workers, 107 (16.51%) OAEs under the size class of 3 workers. OAEs 31, 7, and 3 (4.78%), (1.08%) and (0.46%) comes under the employment size class of 4,5 and 6-9 workers. There is no OAEs under size class of 10 or more workers.

(b) Table 3.6 shows that out of 510 OAEs in rural areas 227 OAEs (44.51%) come under the employment size class of 2 workers. Next comes 192 OAEs (37.65%) under the employment size class of 1 worker. In the employment size class of 3, 4, 5 and 6-9 there are 65,21, 3 and 2 OAEs respectively. Under the size class of 10 or more workers does not exist any OAE.

(c) Table 3.7 shows that out of 138 OAEs in urban areas, 62 (44.93%) OAEs come under the employment size class of 2 workers. Next comes 42 (30.43%) OAEs under size class of 3 workers. OAEs 19, 10, 4, 1 comes under the employment size class of 10 or more workers.

(d) Table 3.19 reveals that out of the total number of 629 establishments in the state, 158(25.12%) establishments come under the employment size class of 2 workers, 136 (21.62%) establishments are under the size class of 3 workers, 134 (21.30%) establishments are under the size class of 6-9 workers, 110 (17.49%) establishments are under 4 workers, 80 (12.72%) establishments are under the size class of 5 workers, 6 and 5 establishments are under the size class of 1 and 10 or more workers.

(e) Table 3.17 shows that out of 483 establishments in rural areas 141 (29.19%) establishments are under the size classes of 2 workers, 115 (23.81%) establishment are under the size classes of 6-9 workers, 89 (18.43%) establishments are under 3 workers, 66 (13.66%) establishments are under 5 workers, 65 (13.46%) establishments are under 4 workers, 4 and 3 establishments are under the employment size classes of 1 and 10 or more workers.

(f) Table 3.18 reveals that out of 146 establishments in urban areas, 47 (32.19%) establishments are under the employment size class of 3 workers, 45 (30.82%) establishment are under 4 workers, 19 (13.01%) establishments are under 6-9 workers, 17 (11.64%), 14 (9.59%) establishments are under the employment size classes of 2 and 5 workers, 2(1.37%) establishments are under employment size class of 1 worker and 2 (1.37%) under employment size class of 10 or more workers.

3.4 *Enterprises with selected characteristics in respect agricultural own-account enterprises and establishments by size class of employment.*

(a) Table 3.2 reveals that there are altogether 1277 agricultural enterprises functioning in Nagaland. Out of these, 648 units are OAEs and 629 are establishments. Of the 648 OAEs 22 (3.40%) enterprises operate seasonally, 104 (16.05%) enterprises have no premises, 546 (84.26%) enterprises operate without power/fuel, 28 (4.32%) enterprises owned by Schedule Castes, 584 (90.12%) enterprises owned by Schedule Tribe and 17 enterprises owned by Other Backward Classes.

(b) The number of agricultural establishments in Nagaland are 629. Of these 629 establishments, 606 (93.34%) establishments are owned by Private Un-incorporate & Partnership, 20 (3.18%) establishments operate seasonally, 144 (22.89%) establishments run without premises, 549 (87.28%) establishments run without power/fuel, 28 (4.45%)

establishments are owned by Scheduled Castes, 532 (84.58%) establishments are owned by Scheduled Tribes and 29 (4.61%) establishments are owned by Other Backward Classes.

(c) Of the 648 OAEs, 289 (44.60%) OAEs are under the employment size class of 2 workers, 211 OAEs are under 1 worker, 107 OAEs are under 3 workers, 31 OAEs are under 4 workers, 7 OAEs under the size class of 5 workers and 3 OAEs under the size class of 6-9 workers. There is no OAE under the size class of 10 or more workers.

(d) Of the 629 establishments, 158 establishments come under size class of 2 workers, 136 establishments are under 3 workers, 134 establishments are under 6-9 workers, 110 establishments are 4 workers, 80 establishments come under the employment size class of 5 workers, 6 establishments come under size class of 1 worker and 5 establishments come under size class of 10 or more workers.

3.5 Table 3.16 & 3.20 reveals that against the total of 2599 persons working in agricultural establishments, 1629 (62.68%) persons are hired workers. Out of these 1629 hired workers, 1297 (79.62%) are working in rural areas and the remaining 332 (20.38%) are working in urban areas. The corresponding total persons working in agricultural establishments in rural and urban areas are 2005 and 594 respectively.

CHAPTER – IV

PRINCIPAL CHARACTERISTICS OF NON-AGRICULTURAL ENTERPRISES.

4.1 *Number of enterprises, total persons and Female employed in own-account enterprises by major activity groups.*

From Table 4.15 it is observed that the largest number of own account enterprises and the number of workers fall in the retail trade activity, the number of enterprises being 13161 (72.74%) and that of workers being 22302 (73.00%). Manufacturing activity comes next with 1676 (14.79%) enterprises and 3542 (11.59%) workers. Other significant activities are Restaurants & Hotels, 570 (3.15%) enterprises and 1245 (4.08%) workers. Other community, Personal Service with 535 (2.96%) enterprises and 1347 (4.41%) workers, Posts and Telecommunications with 406 (2.24%) enterprises and 741 (2.43%) workers, Real Estate Banking & Services 205 (1.13%) enterprises with 421 (1.38%) workers, Transports and Storage 172 (0.95%) enterprises and 217 (0.71%) workers, Sale, Maintenance and Repair 113 (0.63%) enterprises and 14 (0.70%) Wholesale Trade 79 (0.42%) enterprises and 149 (0.49%) workers, Health and Social Work 54 (0.30%) enterprises and 125 (0.41%) workers, education 30 (1.17%) enterprises and 70 (0.23%) workers, etc.

From Table 4.14 it is seen that the largest number of 8397 (37.65%) female workers are engaged in non-agricultural own-account trade enterprises, which have total of 22302 workers. Among the other major activities, Manufacturing 370 (10.45%) females out of 3542 workers, Restaurant & Hotels 588 (47.23%) females out of 1245 workers, Other Community Personal Service 232 (17.22%) females out of 1347 workers, Post and Telecommunications 267 (36.03%) females out of 741 workers, Real Estate Banking and Services 110 (26.13%) females out of 421 workers, Transport & Storage 15 (6.91%) females out of 217 workers, Sale, Maintenance and Repair 22 (10.28%) females out of 214 workers, Whole Trade 52 (33.33%) females out of 156 workers, Public Administration Defence Social Security 17 (11.41%) females out of 149 workers, Health and Social Works 56 (44.08%) females out of 125 workers, Education 28 (40.00%) females out of 70 workers and so on.

4.2 *Number of enterprises, total persons and females employed in establishment by major groups.*

It is observed that in Table 4.25 & 4.28 that the largest number of 2021 (30.98%) establishments out of a total number of 6209 comes under Retail Trade with 17030 (12.10%) workers out of the total workforce of 140732 persons. Next comes in importance from employment point of view in order. Other Community Personal Services with 2377 (14.66%) establishments and 14745 (10.48%) workers, Education with 2288 (14.12%) establishments and 24380 (17.32%) workers, manufacturing with 1411 (8.71%) establishments and 6781 (4.82%) workers, Public Administration Defence Social Security with 1394 (8.60%) establishments and 55971 (39.77%) workers, Restaurants & Hotels with 1355 (8.36%) establishments and 6976 (4.96%) workers, Health and Social Work with 907 (5.60%) establishments and 6919 (4.92%) workers and so on.

Of the total 140732 workers 41594 (29.56%) are female. Out of the total of 17030 workers in retail trade 4375 (25.69%) are females. Other activities with significant work-force are other community per service 14745 workers with 5317 (36.06%) female, manufacturing 6781 workers with 999 (14.75%) female, Public Administration Defence Social Security 55971 workers with 14968 (26.74%) female, Restaurants & Hotels 6976 workers with 2088 (29.93%) female, Health and Social work 6919 workers with 3729 (53.90%) females, Post and Telecommunication 1247 workers with 227 (18.20%) female and so on.

4.3 *Distribution of OAEs/Establishment and their employment with female and hired break up.*

Table 4.3 reveals that out of 34301 non-agricultural enterprises in the state, 18092 (52.74%) are OAEs and 16209 (47.26%) are establishments. The total number of workers working in 18092 OAEs are 30550 out of which 10157 (32.25%) are female workers.

Similarly the total number of workers working in 16209 establishments are 140732 out of which 41594 (29.56%) are female workers and 121501 (86.34%) are hired workers.

4.4 *Distribution of total persons working and the number of hired workers by major activity groups in non-agricultural establishments.*

From table 4.28 it is seen that the largest number of hired workers at 55836 (99.76%) out of the total workers numbering 55971 are engaged in Public Administration, Defence Social Security, followed 23834 (97.76%) hired workers out of 24380 workers in Education, 10085 (59.22%) hired workers out of 17030 workers in retail trade, 8825 (59.85%) hired workers out of 14745 workers in other community personnel services, 4744 (68.00%) hired workers out of 6976 workers in Restaurants & Hotels, 6728 (97.24%) hired workers. Out of 6919 workers in Health & Social work, 5033 (74.22%) hired workers out of 6781 workers in manufacturing, 1250 (100.00%) hired workers out of 1250 workers in Financial Intermediation, 1043 (83.64%) hired workers out of 1247 workers in Posts & Telecommunication, etc.

4.5 *Inter-District comparison of the total persons usually working and female & hired workers in non-agricultural establishments by districts.*

From table 4.31 it is observed that Kohima District has the largest number of 47346 workers, of which 14956 (31.59%) are female & 42020 (88.75%) are hired workers, Dimapur District has 27992 workers, out of which 6327 (22.60%) are female & 23344 (83.40%) are hired workers, Tuensang District has 14654 workers of which 3838 (26.19%) are female & 12639 (86.25%) are hired workers, Mon District has 12938, out of which 4296 (33.20%) are female & 11023 (85.20%) are hired workers, Mokokchung District accounts for 12330 workers, out of which 4348 (35.26%) are female and 11010 (89.29%) are hired workers, Phek district has 9670 workers, of which 3170 (32.78%) are female and 8530 (88.21%) are hired workers, Wokha district is with 8600 workers of which 2440 (28.37%) are female and 7054 (82.02%) are hired workers and Zunheboto District being the last has 7202 workers of which 5881 (81.66%) are hired workers and 2219 (30.81%) are hired workers and 2219 (30.81%) are female workers.

4.6 *Inter-district comparison of Non-agricultural Own Account Enterprises by location.*

Table 4.9, 10 & 11 shows that the largest number of 4561 (25.21%) Non-agricultural own- account enterprises are situated in Kohima District, of those 2011 (44.09%) enterprises are in rural areas and 2550 (55.91%) are in Urban areas. Next comes Dimapur District with only 4522 (24.99%) enterprises, of which 1878 (41.53%) are in rural areas and 2644 (58.47%) are in urban areas. Of the remaining Districts, Tuensang has 1974 (10.91%) enterprises consisting of 1693 (85.76%) rural and 281 (14.24%) urban units, Phek has 1711 (9.46%) enterprises comprised of 1484 (86.73%) rural and 227 (13.27%) urban units, Wokha has 1511 (8.35%) enterprises with 1066(70.55%) rural and 445 (29.45%) urban units, Zunheboto has 1462 (8.08%) enterprises composed of 937 (64.09%) rural and 525 (35.91%) urban units, Mokokchung is with 1380 (7.63%) enterprises, of which 1106 (80.14%) are rural and 274 (19.86%) are urban units and Mon being the lowest with 971 (5.37%) enterprises with breakup of 648 (66.74%) in rural and 323 (33.26%) in urban.

4.7 *Inter-District comparison of non-agricultural establishment by location.*

It is seen from table 4.33 that by far the largest number of 3912 (24.13%) establishments consisting of 961 (24.57%) rural and 2951 (75.43%) urban units are located in Dimapur District. Other Districts show with Kohima having 3795 (23.41%) establishments comprised of 1366 (35.99%) rural and 2429 (64.01%) urban units, Tuensang accounting for 2057 (11.35%) establishments of which 1476 (71.75%) are rural and 581 (28.25%) are urban units, Mokokchung having 1572 (8.69%) establishments, of which 1047 (66.60%) are rural and 525 (33.40%) are urban units, Mon having 1322 (7.31%) establishment, out of which 840 (63.54%) are rural and 482 (36.46%) are urban units, Phek having as its share with 1224 (6.77%) establishments consisting of 909 (74.26%) rural and 315 (25.74%) urban units, Zunheboto with 1196 (6.61%) establishments, of which 821 (68.65%) are in rural and 375 (31.35%) in urban units and Wokha being the last has only 1131 (6.25%) establishments with 734 (64.90%) in rural and 397 (35.10%) in urban units.

4.8 *Hired workers in non-agricultural establishments in relation to total persons employed in major activity group at state level.*

Table 4.28 shows that out of the total persons of 140732 employed in non-agricultural establishments in the state, 121501 (86.34%) are hired workers. The distribution of total workers and hired workers employed against each major activity group are as under:-

4.11 *Female/Child employment in non-agricultural enterprises by district-all activities, Rural, Urban and Combined.*

Table 4.6, 4.7 & 4.8 shows that Kohima district has the largest number of 47346 workers, out of which 14956 (31.59%) are female workers and 182 (0.38%) are child workers. Dimapur district has 27992 workers, out of which 6327 (22.60%) are female and 279 (1.00%) are child workers. Tuensang district accounts for 14654 workers, out of which 3838 (26.19%) are female workers and 77 (0.53%) are child workers. Mon district has 12938 workers, out of which 4296 (33.20%) are female workers and 197 (1.52%) are child workers. Mokokchung district has 12330 workers, out of which 4348 (35.26%) are female workers and 84 (0.68%) are child workers. Phek district has 9670 out of which 3170 (32.78%) are female

workers and 38 (0.39%) are child workers. Wokha district has 8600 workers out of which 2440 (28.37%) are female workers and 120 (1.40%) are child workers, and the lowest number of workers 7202 is in Zunheboto district of which 2219 (30.81%) are female workers and 39 (0.54%) are child workers.

4.12 Average employment in non-agricultural enterprises in terms of total workers and female workers by district and by location.

From Table 4.6 district wise average employment and average female employment for rural areas work out to 6.45 persons to 2.08 females respectively for Mon, 4.15 persons and 1.11 females for Tuensang, 4.22 persons and 1.48 female for Mokokchung, 3.68 persons and 1.26 females for Zunheboto, 3.72 persons and 1.15 females for Wokha, 2.89 persons and 0.97 females for Dimapur, 3.28 persons and 1.26 females for Kohima and for Phek district 3.48 persons and 1.19 females. The corresponding state level rural averages are 3.83 persons and 1.26 females respectively.

Form Table 4.7 average employment and average female employment in urban areas work out to 6.70 persons and 2.37 females workers in Mon, 5.37 persons and 1.21 females in Tuensang, 6.71 persons and 2.35 females in Mokokchung, 3.67 persons and 0.93 female in Zunheboto, 4.91 persons and 1.23 females in Wokha, 4.83 persons and 0.98 females in Dimapur, 8.99 persons and 2.87 females in Kohima and Phek being the last with 7.56 persons and 2.57 females. The corresponding figures for the state level urban areas are 6.44 persons and 1.81 females respectively.

Table 4.8 reveals that the district wise average employment and average female employment in all non-agricultural enterprises are 6.54 persons and 2.17 females respectively

in Mon, 4.41 persons and 1.13 females in Tuensang, 4.89 persons and 1.71 females in Mokokchung, 3.67 persons and 1.15 females in Zunheboto, 4.10 persons and 1.18 females in Wokha, 4.18 persons and 0.97 females in Dimapur, 6.68 persons and 2.22 females in Kohima and 4.23 persons and 1.45 females in Phek district. The state average employment and average female employment are 4.99 persons and 1.51 females respectively.

4.13 *The number of non-agricultural own-account enterprises by size class of total employment by location.*

From Table 4.19 it is observed that of the total 10823 own-account enterprises in rural areas by far the largest number of 10755 (99.37%) have 1 to 5 workers each, 67 (0.62%) enterprises have 6 to 9 workers each, 1 (0.01%) enterprises have 10 or more workers each.

In the urban areas, there are 7269 own-account enterprises, out of which 7238 (99.57%) have 1 to 5 workers each, 28 (0.39%) enterprises employ 6 to 9 workers each, 3 (0.04%) enterprises employ 10 or more workers each.

Out of the total number 18092 own-account enterprises, 17993 (99.45%) have 1 to 5 workers each 95 (0.53%) have 6 to 9 workers each, 4 (0.02%) have 10 or more workers each.

4.14 *Number of non-agricultural establishments by size-class of total employment and by location.*

From Table 4.39, 4.40 and 4.41 it is seen that out of 8154 non-agricultural establishments located in rural areas the largest number of 4624 (56.71%) have 1 to 5 employees each, 2541 (31.16%) have 6 to 9 employees each, 989 (12.13%) have 10 or more employees each.

Out of 8055 non-agricultural establishments located in urban areas 5737 (71.22%) have 1 to 5 employees each, 1624 (20.16%) have 6 to 9 employees each, 694 (8.62%) have 10 or more employees each.

Out of the total 16209 non-agricultural establishments in the state 10361 (63.92%) have 1 to 5 employees each, 4165 (25.70%) have 6 to 9 employees each, 1683 (10.38%) have 10 or more employees each.

4.15 *Inter-district comparison of non-agricultural own-account enterprises by size class of the total employment.*

Out of 10823 (59.82%) non-agricultural own-account enterprises in rural areas, 10755 (99.37%) are in the employment size class of 1 to 5 workers each. Of the later 2008 (18.67%) are in Kohima district, 1872 (17.41%) in Dimapur, 1669 (15.52%) in Tuensang, 1473

(13.70%) in Phek, 1104 (10.26%) in Mokokchung, 1058 (9.84%) in Wokha, 934 (8.68%) in Zunheboto district and Mon district being the last with 637 (5.92%).

Of the 67 (0.62%) enterprises coming in employment size class of 6 to 9 workers, Tuensang district has the highest number of 24 (35.82%) enterprises, 11 each (16.42%) in Phek and Mon, 7 (10.45%) in Wokha, 6 (8.96%) in Dimapur, 3 each (4.78%) in Zunheboto and Kohima and 2 (2.99%) in Mokokchung.

Of the 1 (0.01%) enterprises employing 10 or more workers, 1 (100.00%) workers is in Wokha district. There are no enterprises under the size class of 10 or more workers in other districts.

Out of 7269 (40.18%) non-agricultural own-account enterprises in urban areas, 7238 (99.57%) are in the employment size class of 1 to 5 workers. Of which 2637 (36.43%) are in Dimapur district 2532 (34.98%) in Kohima, 524 (7.24%) in Zunheboto, 445 (6.15%) in Wokha, 323 (4.46%) in Mon, 280 (3.87%) in Tuensang, 272 (3.76%) in Mokokchung district, 225 (3.11%) in Phek district.

Of the 28 (0.39%) enterprises in employment size class of 6 to 9 workers, 18 (64.29%) are in Kohima district, 4 (14.29%) in Dimapur, 2 (7.14%) each in Mokokchung and Phek and 1(3.57%) each in Tuensang and Zunheboto. There are no enterprises under the employment size class of 6 to 9 workers in Mon and Wokha districts.

4.16 *Inter-district comparison of non-agricultural establishments by size class of total employment and by rural/urban location.*

Table 4.39, 4.40 & 4.41 reveals that out of 16209 non-agricultural establishments 1036 (63.92%) fall in the employment size class of 1 to 5 workers. District wise breakup is 2965 (28.62%) in Dimapur, 2349 (22.67%) in Kohima, 1276 (12.32%) in Tuensang, 962 (9.28%) in Mokokchung, 658 (6.35%) in Mon, 748 (7.22%) in Phek, 777 (7.50%) in Zunheboto and 626 (6.04%) in Wokha district, 4165 (25.70%) establishments are under 6 to 9 workers, of which the largest number of 1104 (26.51%) are in Kohima district, 760 (18.25%) in Dimapur, 493 (11.84%) in Mon, 469 (11.26%) in Tuensang, 365 (8.76%) in Wokha, 360 (8.64%) in Mokokchung, 311 (7.47%) in Zunheboto and 303 (7.27%) in Phek district.

Establishments employing 10 or more workers are 1683 (10.38%) numbers, of which the majority of 342 (20.32%) are in Kohima district, 312 (18.54%) in Tuensang 250 (14.85%) in Mokokchung, 187 (11.11%) in Dimapur, 173 (10.28%) in Phek, 171 (10.16%) in Mon, 140 (8.32%) in Wokha and Zunheboto being the last with 108 (7.66%).

Out of 8154 (50.31%) non-agricultural establishments in rural areas, 4624 (56.71%) establishments are in the employment size class of 1 to 5 workers each. Of which 826 (17.86%) establishments are in Tuensang, 863 (18.66%) in Kohima, 614 (13.28%) in

Mokokchung, 628 (13.58%) in Dimapur, 536 (11.59%) in Phek, 322 (6.97%) in Mon, 481 (10.40%) in Zunheboto, and Wokha being the last with 354 (7.66%).

Of the 254 (31.16%) establishments employing 6 to 9 workers, 409 (16.10%) are in Tuensang district, 406 (15.98%) in Mon, 373 (14.68%) in Kohima, 287 (11.28%) in Wokha, 286 (11.26%) in Dimapur, 277 (10.90%) in Mokokchung, 253 (9.96%) establishments are in Zunheboto district and 250 (9.84%) in Phek.

Of the 989 (12.13%) establishments employing 10 or more workers, 241 (24.37%) are in Tuensang district, 156 (15.77%) in Mokokchung, 130 (13.15%) in Kohima, 123 (12.44%) in Phek, 112 (11.32%) in Mon, 93 (9.40%) in Wokha, 87(8.80%) establishments are in Zunheboto and 47 (4.75%) in Dimapur district.

Out of 8055 (49.69%) non-agricultural establishments in urban areas 5737 (71.22%) are in the employment size-class of 1 to 5 workers, of which 2337 (40.73%) are in Dimapur, 1486 (25.90%) in Kohima, 450 (7.84%) in Mon, 348 (6.07%) in Mokokchung, 336 (5.86%) in Mon, 272 (4.74%) in Wokha, 296 (5.16%) establishments are in Zunheboto and Phek being the last with 212 (3.70%).

Of the 1624 (20.16%) establishments employing 6 to 9 workers, 731 (45.01%) are in Kohima district, 474 (29.18%) in Dimapur, 87 (5.38%) in Mon, 83 (5.11%) in Mokokchung, 78 (4.80%) in Wokha, 60 (3.69%) in Tuensang, 58 (3.57%) establishments in Zunheboto, and 53 (3.26%) in Phek District.

Of the 694 (8.62%) establishments employing 10 or more workers, 212 (30.55%) are in Kohima district, 140 (20.17%) in Dimapur, 94 (13.54%) in Mokokchung, 71 (10.23%) in Tuensang, 59 (8.50%) in Mon, 50(7.20%) establishments in Phek, 47 (6.78%) in Wokha and Zunheboto being the last with 21 (3.03%).

4.17 *Distribution of non-agricultural OAEs with selected characteristics such as, seasonally, without premises, power, type of ownership, social group of owner at State level by major activity groups.*

There are 18092 own-account enterprises in the State. As shown in table 4.18 the largest number of 13161 (72.74%) enterprises are engaged in Retail trade, of which 317 (2.41%) operate seasonally, 211 (1.60%) are owned by scheduled tribes, 1856 (14.10%) are owned by scheduled castes and 859 (6.53%) are owned by OBCs.

The next largest number of 2676 (14.79%) enterprises come under manufacturing, of which 120 (4.48%) are seasonal, 28 (1.05%) are without premises, 405 (15.13%) operate without power, 2309 (86.29%) are owned by scheduled tribes, 101 (3.77%) are owned by scheduled castes and 89 (3.33%) are owned by OBCs.

The third largest concentration of 570 (3.15%) enterprises are under restaurants and hotels of which 8 (1.40%) of them are seasonal, 1 (0.18%) is without premises, 195 (34.21%) are without power, 371 (65.09%) are owned by scheduled tribes, 68 (11.93%) are owned by scheduled castes and 30 (5.26%) are owned by OBCs.

Under other Community Personal Services, there are 535 (2.96%) enterprises, of which 8 (0.04%) operate seasonally, 11 (0.06) are without premises 453 (2.50) are without power, 63 (0.35%) are owned by Scheduled tribes, 52 (0.29%) are owned by Scheduled castes and 32 (0.18%) are owned by OBCs.

There are 406 (2.24%) enterprises under Posts and Telecommunications, of which 3 (0.74%) are seasonal, 4 (0.99%) are without premises, 66 (16.26%) are without power, 203 (50.00%) are owned by scheduled tribes, and 75 (18.47%) are owned by scheduled castes and 37 (9.11%) are owned OBCs.

205 (1.13%) enterprises are engaged in Real Estate Banking & Service, among which 2 (0.98%) are seasonal, 5 (2.44%) are without premises, 55 (26.83%) are without power, 95 (46.34%) are owned by scheduled tribes and 47 (22.93%) are owned by scheduled castes and 23 (11.22%) are owned by OBCs.

172 (0.95%) enterprises are engaged in Transport & Storage, of which 110 (63.95%) are seasonal, 5 (2.91%) are without premises, 75 (43.60%) are without power, 142 (82.56%) are owned by scheduled tribes, 12 (6.98%) are owned by scheduled castes and 7 (4.07%) are owned by OBCs.

There are 113 (0.62%) enterprises engaged in Sale Maintenance & Repair, of which 2 (1.77%) are seasonal, 62 (54.87%) are without power, 43 (38.05%) are owned by scheduled tribes, 26 (23.01%) are owned by scheduled castes and 13 (11.50%) are owned by OBCs. There is no enterprise against without premises.

Under Wholesales Trade, there are 79 (0.44%) enterprises , of which 2 (2.53%) are seasonal, 5 (6.33%) are without premises, 71 (89.87%) are without power, 42 (53.16%) are owned by scheduled tribes, 10 (12.66%) are owned by scheduled castes and 2 (2.53%) are owned by OBCs.

In Public Administrative Defence Social Security, there are 76 (0.42%) enterprises, of which 7 (9.21%) are seasonal, 73 (96.05%) operate without power and 8 (10.53%) are owned by scheduled tribes, 4 (5.26%) are owned by scheduled castes and 1 (1.32%) is owned by OBCs. No enterprises is available against without premises.

Health and Social work has 54 (0.30%) enterprises, Of which 2 (3.70%) are operated seasonally, 37 (68.52%) are without power, 39 (72.22%) enterprises are owned by scheduled tribes, 6 (11.11%) are owned by scheduled castes and 4 (7.41%) are owned by OBCs. There is no enterprises against without premises.

4.18 *Distribution of non-agricultural establishments with selected characteristics such as, seasonally, without premises, power, type of ownership, social group of owner at State level by major activity groups.*

From table 4.38 shows that out of 1609 non-agricultural establishments in the State, 5021 (30.98%) establishments are retail trade, of which 4887 (97.33%) are private unincorporated propriety, 72 (1.43%) are private NPI, 20 (0.40%) are Govt. & PSU, 42 (0.84%) are Private others, 98 (1.95%) are seasonal, 79 (1.57%) are without premises, 4664 (92.89%) are without power, 2447 (48.74%) are owned by Scheduled tribes, 1030 (20.51%) are owned by Scheduled castes and 358 (7.13%) are owned by OBCs.

4.19 Female/ Child employment in important industries (importance measured by its share in total woman employment in all Industries).

Table 4.4 reveals that the number of woman and child employment under the major groups of non-agricultural enterprises in the State are 51751 (30.21%) and 1293 (0.75%) respectively.

Of the 51751 women workers in non-agricultural enterprises in the State, 5549 (10.72%) women are employed in community and personal services, 12772 (24.68%) are in Retail trade, 1369 (2.65%) are in manufacturing, 2088 (4.03%) are in Restaurants and Hotels, 334 (0.65%) are in Financial Intermediation, 3785(7.31%) are in Health & Social work, 908 (17.56%) are in Education, 494 (0.95%) are in Telecommunications, 81 (0.16%) are in Transport, 87 (0.17%) are in wholesale trade, 292 (0.56%) are in Real Estate Banking & Services, 14985 (28.96%) are in Public Administrative Defence Social Security and 102 (0.20%) are in Mining and Quarrying.

Table 4.32 reveals that the number of women employment in non-agricultural establishment are 41594 out of which 18101 (43.52%) are in rural areas and 23493 (56.48%) in urban areas. 5928 (14.25%) women workers are employed under private NPI establishments, of which 4824 (81.38%) are in rural areas and 1104 (18.62%) in urban areas. 9820 (23.61%) women workers are employed under private unincorporated proprietary, out of which 2952 (30.06%) are in rural areas and 6868 (69.94%) in urban areas.

Of the 27044 non-agricultural enterprises, 17660 (65.30%) are enterprises are under retail trade, 920 (3.40%) are under community personal services, 3877 (14.34%) are under manufacturing, 1725 (6.38%) are under restaurants and Hotels, 170 (0.63%) are under wholesale trade, 561 (2.07%) are posts and telecommunications, 292 (1.08%) are Transport, 420 (1.55%) are under education, 7 (0.03%) are Financial Intermediation, 189 (0.70%) are under Health & Social Work, 3 (0.01%) are constructions, 369 (1.36%) are in Real Estate Banking & Services, 70 (0.26%) are under Mining and Quarrying, 98 (0.36%) are under Public Administration Defence Social Security, 665 (2.46%) are under no enterprises falling in the category of other activities.

Source of Finance under “assistance from govt source” accounts for 4301 (12.09%) enterprises, out of which 20 (0.47%) are agricultural enterprises and remaining 4281 (99.53%) are non-agricultural enterprises. Of the 20 agricultural enterprises, 14 (70.00%) are rearing of Livestock, 1 (5.00%) is agricultural services and 5 (25.00%) are Fishing etc.

Of the 4281 non-agricultural enterprises, 50 (1.17%) are community, personal services, 102 (2.38%) are retail trade, 115 (2.69%) are manufacturing, 92 (2.15%) are restaurants and hotels, 52 (1.21%) are Financial Intermediation, 1246 (29.11%) are Public Administration Defence Social Security, 60 (1.40%) are Telecommunications, 28 (0.65%) are

Transport, 749 (17.50%) are Health & Social works, 3 (0.07%) each are construction and Wholesale trade, 1731 (40.43%) are under Education 10 (0.23%) are Electricity, Gas and Water, 17 (0.16%) are Mining & Quarrying and 1 (0.02%) is under other activities.

384 (1.08%) enterprises financed by “Borrowing from non-Institutions money lenders, out of which 13 (3.39%) are agricultural enterprise and 371 (96.61%) are non-agricultural enterprises, of the 13 agricultural enterprises, 8 (61.54%) are under rearing of livestock, 5 (38.46%) are fishing etc. No enterprises is available under agricultural services.

Of the 371 non-agricultural enterprises, 225 (60.65%) are under retail trade, 26 (7.01%) are community personal services, 25 (6.74%) are under retail trade, 26 (7.01%) are community personal services, 25 (6.74%) are restaurants and Hotels, 32 (8.63%) are Manufacturing, 2 (0.54%) each are under Financial Intermediation and Wholesale trade, 11 (2.96%) are Education, 14 (3.77%) enterprises on Sale, maintenance and repairs, 9 (2.43%) post and telecommunications, 8 (2.16%) are Health and Social work. There are no enterprises in the categories of Mining and Quarrying, Electricity, Gas and Water, construction and other activities.

Financed by “Borrowing from Financial Institution” account for 349 (0.98%) enterprises, out of which 14 (4.01%) are agricultural and 355 (95.99%) are non-agricultural enterprises.

Of the 14 agricultural enterprises, 10 (71.43%) are rearing of livestock, 1 (0.05%) is agricultural services and 3 (21.43%) are under fishing etc.

Of the 335 non-agricultural enterprises, 175 (52.24%) are retail trade, 26 (7.76%) are community and personal services, 45 (13.43%) are manufacturing, 21 (6.27%) are Restaurants and Hotels, 10 (2.99%) are Transports, 11 (3.28%) are Telecommunications, 5 (1.49%) each are in Wholesale Trade and Sale Maintenance & Repair, 4 (1.19%) are in Financial Intermediation and Health and Social work 12 (3.58%) are in Education, 8 (2.39%) are in Public Administration, Defence Social Security, 7 (2.09%) are in Real Estate Banking and Services, 2 (2.60%) are in Mining and Quarrying. There are no enterprises available in the categories of Electricity, Gas and Water, Construction and other activities.

Enterprises financed by others like NGO’s, Voluntary Organisation are 2273 (6.39%) out of which 3 (0.13%) enterprises are agricultural and 2270 (99.87%) are non-agricultural enterprises.

All the 3 (100.00%) enterprises, 1890 (83.26%) are Community and Personal Services, 20 (0.88%) are Retail Trade, 18 (0.79%) are Manufacturing, 62 (2.73%) are Restaurants and Hotels, 132 (5.81%) are in Education, 111 (4.89%) are in Public Administration, Defence Social Security, 18 (0.79%) are in Manufacturing, 3 (0.13%) each are in Sale, Maintenance and Repair and Financial Intermediation, 2 (0.09%) each are in Wholesale trade, Posts and Telecommunications and Real Estate Banking and Services. No enterprises are available in the categories of Mining and Quarrying, Electricity, Gas and Water, Construction and other activities.

CHAPTER – V

SUMMARY OF RESULTS

5.1. The Economics Census 2005 reveals that there are 35578 enterprises in the state, of which 1277 (3.59%) are agricultural (other than crop production and plantation) enterprises and 34301 (96.41%) non-agricultural enterprises. 19970 (56.13%) of the enterprises are located in the rural areas. The share of rural enterprises among the agricultural and non-agricultural enterprises are 4.97% and 95.03% respectively. 50.74% of the agricultural enterprises and 52.74% of non-agricultural enterprises are own-account enterprises and the remaining are establishments.

5.2 Of the total of 175169 persons usually working in all enterprises, 3887 (2.22%) persons are engaged in agricultural enterprises. The rural areas accounts for 76.10% of employment in agricultural activities. Hired workers constitute 41.91% of total rural workers in such enterprises. The total persons engaged in non-agricultural activities is 171282 of which 121201 (70.94%) are hired workers. While 42.39% of total persons working in non-agricultural enterprises are in rural areas. The share of hired for rural areas is 38.54% of all hired workers.

5.3. Of all enterprises 2.41 are seasonal, 2.41% are working without premises, and 77.56% operated without power. 50.34% of the total enterprises are owned by scheduled tribes, 11.76% are owned by scheduled castes and 5.17% enterprises are owned by other backward classes. Private N.P.I and Private Un-incorporated Propriety enterprises constitute 35.13% of all enterprises.

5.4 Six major activity group viz. Manufacturing, Retail Trade, Restaurants and Hotels, Public Administration, Defence Social Security, Education and Other Community and Personal Services apportion among them 86.83% of all enterprises and 88.22% of all workers. The six groups share of female workers is 26.51%. the same pattern of dominance of these activity groups prevail uniformly in both rural and urban areas with 81.63% of all rural establishments and 85.89% of rural employment and 82.87 % of all urban establishments and 89.11% of urban employment coming under these six activity group.
